“RESOLUTION NO. 2023-188

A RESOLUTION ADOPTING THE CY 2024 MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) PLAN OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, Section 16 of Republic Act 7160 or the Local Government Code of 1991 provides that “every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2009-09 (Subject: Unified Actions Against Illegal Drugs and other Substances), which mandates that it is a principal responsibility of the local authorities to support all government efforts to address illegal drugs and other substances;

WHEREAS, Joint Memorandum Circular No. 2018-01 of the Department of the Interior and Local Government and the Dangerous Drugs Board (DDB) reiterated the organization of the Local Anti-Drug Abuse Councils enumerating their specific roles and responsibilities and providing for implementing guidelines for their functionality and effectiveness;

WHEREAS, DDB Board Regulation No. 02 has mandated the local government to provide interventions that shall include, but not limited to, education and health, psychological/spiritual/physical activities, and livelihood or employment education;

WHEREAS, DILG Memorandum Circular 2021-044 provides the menu of anti-drug abuse programs and activities that the LGUs may conduct, which include assisting or enhancing the enforcement of RA 9165, giving priority to educational programs on drug abuse prevention and control and rehabilitation and treatment of drug dependents;

WHEREAS, the DILG has initiated the “Buhay Ingatan Droga Ayawan” (BIDA) Program which is in support to Executive Order No. 66, Series of 2018 and institutionalized in the Philippine Anti-Illegal Drugs Strategy (PADS);

WHEREAS, the BIDA Program is a holistic approach in countering the proliferation of illegal and dangerous drugs as it strengthens supply and demand reduction efforts by galvanizing the support of the community, duty-bearers and other stakeholders in drug use prevention, law enforcement and rehabilitation;

WHEREAS, the PPAs under the CY 2024 MADAC Plan were extracted from the Local Anti-Drug Plan of Action of the municipality for CY 2023-2025;

WHEREAS, funding for the various PPAs indicated in the MADAC Plan for CY 2024 shall be coming from the General Fund, Peace and Order Fund, Support to ADAC programs, San Nicolas Healing Time Program and funds coming from external sources.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan assembled in session to adopt the CY 2024 Municipal Anti-Drug Abuse Council (MADAC) Plan of the Municipality of San Nicolas, Province of Ilocos Norte.

On motion of Member Norberto S. Dadiz, Jr., duly seconded, the foregoing resolution was unanimously approved.
