#### "MUNICIPAL APPROPRIATION ORDINANCE NO. 2023-15

AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY MILLION TWO HUNDRED TWENTY FIVE THOUSAND FOUR HUNDRED NINETEEN PESOS (P30,225,419.00) REPRESENTING THE MUNICIPALITY'S SHARE IN TOBACCO EXCISE TAX UNDER RA 7171 FY 2020 COLLECTION (LBM 86) AND TWO HUNDRED TWENTY THOUSAND ONE HUNDRED THIRTY SEVEN PESOS (P220,137.00) FROM RA 8240 FY 2020 COLLECTION (LBM 86), FOR A TOTAL AMOUNT OF THIRTY MILLION FOUR HUNDRED FORTY FIVE THOUSAND FIVE HUNDRED FIFTY SIX PESOS (P30,445,556.00) FOR THE VARIOUS PROGRAMS AND PROJECTS OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AND AUTHORIZING THE USE OF THE SAME.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 expressly provides that: The Sangguniang Bayan as the legislative body of the municipality shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and the inhabitants pursuant to Section 16 of this code and the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall generate and maximize the use of resources and revenue of the development plans, program objectives and priorities of the municipality as provided for under Section 18 of this Code;

WHEREAS, The Presiding Officer presented the amount of Thirty Million Two Hundred Twenty Five Thousand Four Hundred Nineteen Pesos (P30,225,419.00) from the municipality's share in Tobacco Excise Tax Under RA 7171 FY 2020 Collection (LBM 86) and Two Hundred Twenty Thousand One Hundred Thirty Seven Pesos (P220,137.00) from RA 8240 FY 2020 Collection (LBM 86), for a total amount of Thirty Million Four Hundred Forty Five Thousand Five Hundred Fifty Six Pesos (P30,445,556.00) for various programs and activities of the municipality intended for the farmers;

WHEREAS, as per certification issued by the Local Finance Committee, there is an available amount of Thirty Million Two Hundred Twenty Five Thousand Four Hundred Nineteen Pesos (P30,225,419.00) representing the municipality's share in Tobacco Excise Tax under RA 7171 FY 2020 Collection (LBM 86) and Two Hundred Twenty Thousand One Hundred Thirty Seven Pesos (P220,137.00) from RRA 8240 FY 2020 Collection (LBM 86), both under Notice of Authority to Debit Account Issued (NADAI) 01-101252 dated December 29, 2022 and March 30, 2023;

WHEREAS, the total amount of Thirty Million Four Hundred Forty Five Thousand Five Hundred Fifty Six Pesos (P30,445,556.00) shall be appropriated for the agro-industrial, cooperative, livelihood and infrastructure projects and programs for all farmers of the municipality:

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

**SECTION 1.** *Sources of funds*. The sources of funds in the total amount of Thirty Million Four Hundred Forty Five Thousand Five Hundred Fifty Six Pesos (P30,445,556.00) shall from the municipality's share in tobacco excise tax under RA 7171 FY 2020 Collection (LBM 86) and from RA 8240 FY 2020 Collection (LBM 86);

**SECTION 2**. *Authorization*. The total amount of Thirty Million Four Hundred Forty Five Thousand Five Hundred Fifty Six Pesos (P30,445,556.00) is hereby appropriated and approved.

**SECTION 3.** *Use of Funds.* The total amount of Thirty Million Four Hundred Forty Five Thousand Five Hundred Fifty Six Pesos (P30,445,556.00) from the municipality's share in tobacco excise tax under RA 7171 FY 2020 Collection (LBM 86) and from RA 8240 FY 2020 Collection (LBM 86) is hereby appropriated, as follows:
