#### **"MUNICIPAL ORDINANCE NO. 2023-16**

## AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF LEAÑO AVENUE, WEST OF THE SAN NICOLAS TOWN PLAZA, TO BE USED FOR THE LINGGO NG KABATAAN FOOD FAIR AND THE MERCATO NI NANAY CES TRADE EXHIBITS DURING THE DURATION OF AUGUST 18, 2023 TO AUGUST 26, 2023.

WHEREAS, the Local Government Unit of San Nicolas thru the SK Federation and the Honorable Vice-Governor of Ilocos Norte, Cecilia Araneta-Marcos has come up with a program, to conduct a Holiday Food Fair and trade exhibit;

WHEREAS, the cravings for variety of street and locally made foods, and a trade exhibit is part and parcel of the joint undertaking and a more spacious area is needed to accommodate vendors and retailers, as well as the public;

WHEREAS, a portion of Leaño Road was identified as possible area to accommodate the putting up of temporary stalls;

**NOW, THEREFORE, BE IT ENACTED** by the Sangguniang of the Municipality of San Nicolas, Province of Ilocos Norte assembled in session, that:

SECTION 1. Authority. The Sangguniang Bayan is authorized by law specifically the Local Government Code of 1991 to enact measures relative to the use and closure of roads within its territorial jurisdiction.

SECTION 2. Purpose. A portion of Leaño Avenue shall be closed from August 18, 2023 to August 26, 2023, to be used as the venue for the San Nicolas Holiday Food Fair, a program of the Federated Sangguniang Kabataan, and the "Mercato ni Nanay Ces" of the Honorable Vice-Governor Cecila Araneta-Marcos

**SECTION 3.** This ordinance shall take effect upon approval.
