A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF AGRICULTURE THRU THE HONORABLE DR. ANNIE Q. BARES, DVM, REGIONAL EXECUTIVE DIRECTOR OF THE DEPARTMENT OF AGRICULTURE – REGIONAL FIELD OFFICE I, TO PROVIDE FINANCIAL ASSISTANCE FOR THE REHABILITATION/CONSTRUCTION OF VARIOUS FARM TO MARKET ROADS, CANAL LININGS OF SMALL WATER IMPOUNDING PROJECTS WITHIN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, it is imperative for the Local Government Unit to draw the road map aimed to improve the quality of life of its inhabitants, pursuant to Section 16 and 17 of the Local Government Code of 1991;

WHEREAS, consistent with the National Government's program of poverty alleviation, the municipality has adopted plans and programs to address the needs of the farmers to enhance their earning capacity and ultimately improve their quality of life;

WHEREAS, one of the priority concerns of the present administration is the rehabilitation and construction of Farm-to-Market Roads within the municipality which will in the end redound to the benefit of the citizens especially the underprivileged farmers;

WHEREAS, most of these projects remain unimplemented due to the inadequate resources of the Municipal Government, hence the LGU is constrained to seek the assistance of National Government agencies tasked in the implementation of the agricultural programs;


On motion of Member Inno Ma. Angelo Paulo O. Hernando, duly seconded, the foregoing resolution was unanimously approved.
