“RESOLUTION NO. 2023-226

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE DEVELOPMENT BANK OF THE PHILIPPINES REGARDING THE SALARY LOAN FACILITY (SLF).

WHEREAS, DBP has launched a salary loan facility to provide financial assistance in the form of salary loans to qualified officials and employees of the municipality of San Nicolas in accordance with the DBP Consumer Lending for Officials and Employees of LGU San Nicolas;

WHEREAS, in consideration of DBP’s agreement to extend salary loan facility to the said borrowers, the LGU has agreed to fulfill certain obligations relative to its accreditation, the eligibility of the Borrowers, and the remittance to DBP of the monthly amortizations due, in accordance with the SLF Guidelines;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Development Bank of the Philippines regarding the Salary Loan Facility (SLF).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
