"MUNICIPAL ORDINANCE NO. 2023-17

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF LEAÑO AVENUE, WEST OF THE SAN NICOLAS TOWN PLAZA, TO BE USED FOR THE CONDUCT OF A FOOD FAIR IN CELEBRATION OF MARCOS DAY AND THE FEAST OF ST. NICOLAS DE TOLENTINO ON SEPTEMBER 8-11, 2023.

WHEREAS, the Local Government Unit of San Nicolas joins the celebration of Marcos Day and have also scheduled various activities in celebration of the Feast of St. Nicolas de Tolentino;

WHEREAS, the cravings for variety of street and locally made foods, and a trade exhibit is part and parcel of the activities more spacious area is needed to accommodate vendors and retailers, as well as the public;

WHEREAS, a portion of Leaño Road was identified as possible area to accommodate the putting up of temporary stalls;

NOW, THEREFORE, BE IT ENACTED by the Sangguniang of the Municipality of San Nicolas, Province of Ilocos Norte assembled in session, that:

SECTION 1. *Authority.* The Sangguniang Bayan is authorized by law specifically the Local Government Code of 1991 to enact measures relative to the use and closure of roads within its territorial jurisdiction.

SECTION 2. *Purpose.* A portion of Leaño Avenue shall be closed from September 8-11, 2023 to be used as the venue for the Food Fair, in celebration of Marcos Day and the Feast of St Nicolas de Tolentino.

SECTION 3. This ordinance shall take effect upon approval.
