**“RESOLUTION NO. 2023-260**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE CONTRACT OF AFFILIATION BETWEEN THE MUNICIPALITY AND THE DIVINE WORD COLLEGE OF LAOAG FOR THE COMMUNITY HEALTH NURSING DUTY OF THEIR BACHELOR OF SCIENCE IN NURSING STUDENTS FOR THE INCOMING SCHOOL YEAR 2023-2024 ONWARDS.**

**WHEREAS**, the LGU agrees and allows the affiliation and training of Bachelor of Science in Nursing students of the Divine Word College of Laoag subject to policies, procedures and guidelines covering the Affiliation and Training of Students of the Department of Health, Hospital/Rural Health Units and other Health Agencies and that the Chief of the agency representing the LGU shall comply with or observe the provisions in the Joint Administrative Order between the Department of Health and Commission on Higher Education, AO No. 2013-0034 and CMO No. 35, Series of 2013 respectively;

**WHEREAS**, the affiliating students of the Divine Word College of Laoag shall pay the corresponding amount in compliance with the Standard Rates of Affiliation Fees for Nursing Students, as provided for in DOH Administrative Order No. 5-A s. of 1996, Section 9.1.7. as affiliation fee to the LGU or to any of its authorized agent/s with the aforementioned undertaking as follows:

P60.00/student for 50-80 hours  
P40.00/student for 30-49 hours  
P30.00/student for 10-29 hours  
P20.00/student for 01-09 hours

**WHEREAS**, Sec.2 of the DOH Administrative Order states that the Department of Health is making available hospitals and accredited government community health resources for the learning and training of students from health professional schools;

**WHEREAS**, under the Local Government Code, Sec. 22(c) of R.A. 7160 it provides:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

XXX XXX XXX  
(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

**WHEREAS**, the municipal mayor is empowered to enter into contracts or MOA’s in behalf of the municipality. This is based on Section 444(b)(1)(vi) of the LGC of 1991 which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.  
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan on the proposed MOA, it was:

**RESOLVED, AS IT IS HEREBY RESOLVED** to authorize the Local Chief Executive to represent the municipality and Sign the Contract of Affiliation between the Municipality and the Divine Word College of Laoag for the Community Health Nursing Duty of their Bachelor of Science in Nursing Students for the Incoming School Year 2023-2024 Onwards.

**RESOLVED FURTHER** to transcribe copies of this resolution and furnish same to all concerned for their information, guidance and appropriate action.

On motion of Member Chona P. Hernandez, duly seconded, the foregoing resolution was unanimously approved.
