"RESOLUTION NO. 2023-265

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE I FOR THE REPAIR AND REHABILITATION OF SMALL SCALE IRRIGATION PROJECTS OF THE MUNICIPALITY PARTICULARLY AT BRGY. 19, SAN LORENZO AMOUNTING TO ONE HUNDRED THOUSAND PESOS (P100,000.00) AND BRGY. 24, STA. MONICA AMOUNTING TO ONE HUNDRED THOUSAND PESOS (P100,000.00).

WHEREAS, the Department of Agriculture (DA) promotes agricultural development through a bottom-up self-reliant farm systems approach that puts emphasis on social justice, equity, productivity, and sustainability in the use of agricultural resources;

WHEREAS, the rehabilitation of Small Scale Irrigation Projects (SSIPs) is an identified intervention of the Department of Agriculture to boost agricultural development in the regions and increase the production of rice and other high value crops;

WHEREAS, the rehabilitation of Small Scale Irrigation Projects (SSIPs) is one of the projects funded under the Quick Request Fund (QRF) of the Department of Agriculture (DA) to restore the agricultural productivity of "MLGU-San Nicolas" that was disturbed when Super Typhoon 'Egay' ravaged llocos Region.

WHEREAS, the Local Government Code of 1991 encourages complementation in the implementation of government project between the local government and the national government through cooperation in the use of resources such as funds, facilities, and services;

WHEREAS, the following vital projects for agricultural development and production are as follows, to wit:

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. - (a) Every local government unit, as a corporation, shall have the following powers: ххх ххх

XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. -xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Department of Agriculture-Regional Field Office I for the repair and rehabilitation of Small Scale Irrigation Projects of the municipality particularly at Brgy. 19, San Lorenzo amounting to One Hundred Thousand Pesos (P100,000.00) and Brgy. 24, Sta. Monica amounting to One Hundred Thousand Pesos (P100,000.00).

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Erico R. Ruiz, Jr., duly seconded, foregoing resolution was unanimously approved.
