“RESOLUTION NO. 2023-275

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO REPRESENT THE MUNICIPALITY AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY AND THE FARMER ASSOCIATIONS IN CONNECTION WITH THE PROVISION OF THREE (3) UNITS HAULING TRUCKS AND SEVEN (7) UNITS HAND TRACTOR FROM RA 7171 FUND.

WHEREAS, the “LGU-San Nicolas” is primarily tasked, by virtue and existing laws of the land, to assist and/or support various qualified farmer organizations and cooperatives in establishing various projects and programs geared towards agricultural development;

WHEREAS, the “LGU-San Nicolas” spearheads the provision of agricultural projects particularly farm machineries and equipment and post-harvest facilities to the different farmers association and cooperative of the municipality;

WHEREAS, the following farmer associations are of good standing and duly registered Farmer’s Association under the Securities and Exchange Commission (SEC) and accredited as Rural Based Organization (RBO) by the LGU-San Nicolas, to wit:

- a) Hauling Trucks
 - 1) Brgy. San Pablo Tobacco Farmers Association Inc.
 - 2) Brgy. San Agustin Tobacco Farmers Association Inc.
 - 3) San Nicolas, Ilocos Norte Mango Growers and Contractors Association Inc.
- b) Hand Tractors
 - 1) Brgy. 03 San Ildefonso Farmers Association Inc.
 - 2) Brgy 07 San Miguel Farmers Association Inc.
 - 3) Timba Farmers Association Inc.
 - 4) Timpuyog ti Bugnay Farmers Association Inc.
 - 5) Sitio Barikir Farmers Association Inc.
 - 6) Brgy. 23 Sta. Cecilia Small Water Impounding System Irrigators Association Inc.
 - 7) Sitio Tamurong Tobacco Farmers Association Inc.

WHEREAS, the above-mentioned farmers associations have been yearning to have Hauling Trucks and Hand Tractors to be used in their agricultural land areas;

WHEREAS, the “LGU-San Nicolas” shall grant the “Farmers Association” Three (3) Hauling Trucks and Seven (7) Hand Tractors for them to use in barangay and adjacent barangays;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx xxx xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby RESOLVED by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to represent the municipality and sign the Memorandum of Agreement (MOA) between the municipality and the Farmers Associations in connection with the provision of Three (3) Units Hauling Trucks and Seven (7) Units Hand Tractor from RA 7171 Fund.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Erico R. Ruiz Jr., duly seconded, foregoing resolution was unanimously approved.


