"MUNICIPAL APPROPRIATION ORDINANCE NO. 2023-25

AN ORDINANCE RATIFYING THE LOAN AGREEMENT AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF SAN NICOLAS, ILOOCOS NORTE, REPRESENTED BY MAYOR ANGEL MIGUEL L. HERNANDO AND THE LANDBANK OF THE PHILIPPINES, REPRESENTED BY ITS HEAD, ILOCOS NORTE LENDING CENTER – JESUS E. ALEGRE, JR., IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) TO AUGMENT THE MUNICIPALITY'S FUND IN THE ACQUISITION OF 4.8 HECTARES LOT TO BE USED AS THE SITE OF THE SAN NICOLAS GOVERNMENT CENTER.

WHEREAS, the LGU San Nicolas, Ilocos Norte has applied a loan of One Hundred Fifty Million Pesos (P150,000,000.00) to the Landbank of the Philippines to augment the municipality's fund in the acquisition of 4.8 hectares lot to be used be used as the site of the San Nicolas Government Center;

WHEREAS, the said application was approved by the Landbank of the Philippines and on December 1, 2023, the Municipality of Nicolas represented by the Hon. Mayor Angel Miguel L. Hernando entered into a loan agreement with the Landbank of the Philippines represented by its Head, Ilocos Norte Lending Center – Jesus E. Alegre, Jr., pursuant to Resolution No. 2023-261 passed by the Sangguniang Bayan, in relation to the loan agreement;

NOW THEREFORE, BE IT ENACTED by the Sangguniang Bayan of the Municipality of San Nicolas in regular session assembled, that:

SECTION 1. The Loan Agreement, Assignment and other supporting documents to the loan in the amount of One Hundred Fifty Million Pesos (P150,000,000.00) entered into by and between the Municipal Government of San Nicolas, Ilocos Norte, represented by Hon. Mayor Angel Miguel L. Hernando and the Landbank of the Philippines, represented by its Head, Ilocos Norte Lending Center, Jesus E. Alegre, Jr., is hereby ratified;

SECTION 2. *Effectivity.* This ordinance shall take effect upon approval.
